PREPAID TUITION PLAN AGREEMENT – EASTMAN SCHOOL OF MUSIC

The student has 4 6 8 qualifying semesters remaining in the school of enrollment, commencing with the **Fall semester (year) 2011**.

The University's current tuition rate for the school of enrollment is **\$20,520.00** per semester for students admitted for Fall 2009 or after, **\$19,745.00** per semester for students admitted for Fall 2008, **\$19,025.00** for students admitted for Fall 2005-2007 and **\$20,520.00** for dual degree students who entered in Fall 2008 and after.

The Prepayment due date is **August 10, 2011**, if enrolling as of the fall term, or December 10, 2011, if enrolling as of the spring term. Payment must be made by wire transfer or by check, mailed to our office. Wire transfer instructions are found on our website: www.rochester.edu/adminfinance/bursar.

1. **The Plan**

The University will accept prepayment in full of the above student's tuition until graduation at the tuition rate in effect for the next full academic year (the "Current Tuition Rate").

The Plan is offered for undergraduate students enrolled full-time in the Eastman School of Music

Students must have remaining prior to graduation not less than four (4) nor more than eight (8) semesters commencing with the next full academic year (the "Qualifying Semester").

2. **Prepayment**

On or before the Prepayment Due Date stated above, the Participant (payer) will pay to the University an amount equal to the current tuition rate multiplied by the number of qualifying semesters as stated above. This amount is the "Total Prepaid Tuition". The University will accept timely payment of the Total Prepaid Tuition as payment in full of the student's tuition in the school of enrollment for the qualifying semesters. The prepayment covers only basic tuition charges as set by the University from time to time. Other University charges, such as room and board fees, book charges and charges for credit hours exceeding full-time study, will be payable in accordance with the University rules as set from time to time. Prepayment must be made by check or wire transfer. The University is unable to accept payment by credit card.

3. **Transfer Between Schools**

If the student transfers from the school of enrollment to another qualifying school of the University of Rochester before completing the number of semesters covered, the unused portion of the total prepaid tuition will apply to tuition in such other school which will thereafter constitute the school of enrollment.

4. **Special Programs**

If the student participates in a special program sponsored by the University which requires off-campus study, the prepaid tuition for the semester(s) involved will be applied against the tuition charged for the special program at the tuition rate in effect for that academic year. Any prepaid tuition in excess of such actual program tuition charges will be refunded to the student within 30 days after being billed. Students participating in special programs sponsored by other Universities will receive refunds of tuition at the rate in effect when participation in the plan began.

5. **Inactive Status, Withdrawal or Expulsion**

If the student is granted inactive status, withdraws permanently or is expelled from the University, the prepaid tuition for the semester during which such action occurs will be applied and, in certain cases, refunded in part, in accordance with the University's general rules concerning tuition refunds as then in effect. Prepaid tuition for all future qualifying semesters will be refunded to participant (payer).

6. **Funds and Refunds**

The total prepaid tuition shall belong to the University exclusively from and after its receipt thereof, without obligation to account to participant (payer) for any payment or income earned thereon. Participant's rights are limited to the right to receive refunds provided in this agreement, without interest. The University shall have the right to offset any tuition or non-tuition charges incurred by the student.

7. **Concerning this Agreement**

If any part of this agreement is held to be invalid under any law, all other parts of this agreement shall not be affected. This agreement shall be governed by and construed in accordance with the laws of the State of New York.

The rights and privileges of the University there under shall insure to the benefit of its successors and assigns, and the duties and obligations of participant (payer) shall bind the heirs, personal representatives, successors and assigns of participant (payer). The benefits of this agreement are not assignable to any student other than the "student" named herein. The parties hereto have entered into this agreement as of the date appearing at the beginning hereof.
