Catcher's Camp 2011 Overview

Pete Dawes' "Catcher's Camp" at the University of Rochester will be 2 hour sessions that focus on the techniques of the catching position. The fundamentals of the position will be taught over 6 sessions once per week at the University of Rochester Athletic Facility which is an astro turf indoor complex. The surface allows for a lot of drill areas to execute and refine the catching position. The camp places emphasis on the position by working on a multitude of drills that focus on throwing mechanics, blocking, receiving, defensive positioning, signs, pitch calling, bunt coverage and leadership.

The camp has been in existence for the past 13 years were Coach Dawes has developed many practice drill mechanics with repetitions and since the beginning the camp has prepared both boys and girls to excel at the catching position. Most of the catchers have made youth All-Star teams and been named to organized baseball All-League teams by developing the vital mechanics that leads to success behind the plate. The camp has produced many High School All-County, All-State and Empire Games players from around the state. Former campers have gone on to play College Baseball at the Division I level and professional baseball. Most recent success story is former camper Cory Brownsten from Lockport H.S, Lockport, New York. Cory is from the Buffalo area were he traveled to Rochester from Lockport to attend camp for 6 years. Cory received many High School honors from Section VI and then attended Monroe Community College where Coach Dawes worked with him for 2 more years at the school and at the camp. In 2008 Cory Brownsten was chosen as the NJCAA Easton Defensive Player of the Year and received the prestigious honor of receiving the NJCAA Rawlings "Gold Glove Award". He also was honored as a 1st team All-American as the top catcher in all of NJCAA. Cory then moved o0nto the University of Pittsburgh where he started both seasons for the Panthers. He was an All -Big East selection and was then drafted by the Atlanta Braves (15th Round) in the 2010 Major League Draft.

The University of Rochester catchers have the privilege of working with Coach Dawes to hone their skills. Through his 25 years of coaching at Monroe CC Coach Dawes and his staff have developed many drills for the catching position. These techniques, drills and philosophies will be taught at the catcher's camp and are a major part of the catchers practice routine at the U of R.

Bob was a played at MCC and earned NJCAA Region III 1st team, Northeast District Player of the Year, Northeast District 1st team, NJCAA 2nd team All-American while hitting .420 with 11 home runs and 54 RBI's in 1989. Bob led his team to the JUCO Division I College World Series. Bob was drafted and held in the 25th round in 1988 by the Houston Astros. Bob signed with Astros after his sophomore year at MCC and made it to Spring Training with the major league club finishing his career in Double A Ashland.

Ed Kahovec Assistant Baseball Coach University of Rochester

Ed was a 4 year letter winner at Rochester and a 3 time all league selection. Ed. Senior year, he was selected as an All-Region player. After graduation, Coach Kahovec signed a professional contract to play in German. Last year, Kahovec served as an assistant coach on the U of R baseball staff earning Assistant coach of the year in the conference.
