<i>vidnewf</i>	Median Voter	Median voter ideological position (<i>Source</i> : Budge et al. 2001, Kim and Fording 1998)
<i>gidnewf</i>	Government	Government Ideological Position (<i>Source</i> : Budge et al. 2001, Kim and Fording 1998)
<i>ue</i>	Unemployment	Unemployment rate (<i>Source</i> : OECD, National Accounts; Economic Outlook and Reference Supplement; and Labour Force Statistics)
<i>pop65</i>	Age distribution	Pension-age (65+) share of the population (<i>Source</i> : UN, Demographic Yearbook)
<i>cpi</i>	Inflation	Consumer-price inflation (<i>Source</i> : IMF, International Financial Statistics)

<i>hr</i>	Government hazard rate	The inverse of the incumbent government's actual duration (<i>Source</i> : Franzese 2002)
<i>sdrw</i>	Income skew variability	Five-year, centered, moving standard deviation of RW (<i>Source</i> : Franzese 2002)
<i>vp</i>	Voter participation	Turn out rate in the lower-house national elections. Interpolated by four-year moving average (<i>Source</i> : Franzese 2002)
<i>rw</i>	Income skew	Relative wage position of manufacturing workers to the GDP per capita. Normalized by GINI indexes. US-86 equals 1 (<i>Source</i> : Franzese 2002)
<i>ttnz17a</i>	Welfare spending trend	Average $T\&T$ in other countries in the sample year. (<i>Source</i> : Franzese 2002)
<i>prf</i>	PR	Proportional representation electoral system
<i>pocatholic</i>	Catholic	Catholic share of population (<i>Source</i> : Wilensky 2002)
