

Lack of an integrated work plan – The fact that the team doesn't have a forward-looking, integrated work plan yet makes project management a challenge	High	High	Workday will be assigning a new resource to develop and manage the integrated work plan. Individual team work plans already exist; these just have to be pulled together with interdependencies and timeframes identified.	10/1/18	
PowerFaids integrations – There are eight complex integrations that need to be built from UR's financial aid system (PFAIDS) into WD. This workaround is necessitated because we are not using WD's Financial Aid module.	High	High	Workday delivered the first set of PowerFaids integrations earlier than scheduled but technical issues remain to be resolved. WD has prioritized this activity so there is ample time to test and make adjustments before go-live.	11/30/18	
Impact of product maturity on project methodology – due to the delivery of product functionality throughout the duration of the project, it is challenging – if not impossible – to apply WD's project methodology or other tried-and-true project management practices to minimize project risk	High	High	 Ask WD to relax established WD practices and approach to help cope with product immaturity Close partnership with UR, WD, and Deloitte to constantly evaluate critical path activities and adjust approach as needed Integrated QA Assessment throughout project 	1/1/19	
Maturity of Product – Workday's ability to deliver on all UR blockers identified as critical for go-live	High	High	WD Product is working closely with the UR project team to evaluate completeness of functionality via on-site visits from Product, weekly meetings with project leads, etc.	1/15/19	
Change Management – moving from a 30+ year old legacy system to a modern, object-oriented system will require a significant culture change. WD is also reengineering how student administration works. Student Finance SIG

- Meeting weekly with UR Finance Representatives regarding configuration and moving completed configuration into Production
- Scheduled monthly SIG meetings to discuss topics such as reporting, allocations (mandatory fee), change management, and future state configuration for budget to actuals

Summary of Changes

- All Student charges, payments, etc. will happen on a real-time versus (SIS) batch basis
- Additional worktags will be on all student related transactions (student, academic period, FT/PT, Program of Study, Status)
- Tuition revenue categories will remain as is
- Consolidation of mandatory fee existing revenue categories into one (RC14570 – Mandatory Fee) for posting, then allocating to:
 - Student Activity Fee
 - Transportation Fee
 - Housing Social Fee
 - CMC Box Rental Fee
 - Mandatory Health Fee
- New Student Receivables Billed (11615) ledger account
- Collapsing of tuition FAOs 1 per each school for Deferred Revenue
