MEMORANDUM OF UNDERSTANDING OR PROFESSIONAL SERVICES

THIS IS A MEMO OF UNDERSTANDING, made this 4th day of December, 2024, by and between Compeer Rochester, Inc., having its principal office at Monroe Square, 259 Monroe Avenue, Rochester, NY 14607, hereinafter referred to as "COMPEER," and University of Rochester, having its principal office at 500 Joseph C. Wilson Blvd. Rochester, NY 14627, hereinafter referred to as "UNIVERSITY."

Section 1. Term

COMPEER shall commence performance of the services required under this Memo of Understanding on 01 January 2025 for a term of one year. The parties may agree to renew this MOU on or before 01 January 2026.

Section 2. Scope of Services

COMPEER shall provide:

- Full and final responsibility for client care.
- Student volunteer onboarding, including background checks and training. Student volunteer placement in 1:1 youth or adult matches.
- Monitoring of volunteer/client matches on a monthly basis.
- Ongoing student training opportunities throughout the year.
- Termination of volunteers/matches when expectations set forth in onboarding and training process are not met at the discretion of the volunteer program coordinator.

UNIVERSITY will be responsible for:

- Ensuring students, faculty and University Administration are aware of club existence, policies, and procedures.
- Planning and implementation of club administration, curriculum content, and faculty appointments.
- On campus volunteer recruitment via signage, electronic communications, and word of mouth/ambassadorship.
- Campus-led or hosted group volunteer networking or enrichment events, should the club wish to provide such events.

Section 3. Equipment, Materials and Supplies

Unless specified elsewhere in this Memo of Understanding, all equipment, materials and supplies necessary to perform club activities required by this Memo of Understanding shall be furnished by the UNIVERSITY at its own expense.

Section 4. Termination

Either party may terminate this Memo of Understanding on ten (10) days advance written notice of a material breach by the other party that is not substantially cured by the party within twenty (20) days of receipt of such notice.

Section 5. Authorized Agents

The following individuals are designated as the Authorized Agent of COMPEER and UNIVERSITY for all communications pursuant to this Memo of Understanding:

Section 6. Status as Partner

UNIVERSITY students, faculty, and administrative staff represent and warrant that they are a community partner of COMPEER and shall not claim to be officers or employees of COMPEER, nor any of its affiliates, and further shall not make any claim, demand or application to or for any right or privilege applicable to an officer or employee of COMPEER.

Section 7. Trademark and Licensing

UNIVERSITY shall not use the name, nor the logo of COMPEER or any of its affiliates on letterhead, business card, or on any promotional material unless approved by COMPEER.

Section 8. Compensation

There shall be no expected monetary compensation between either party for the purposes of this agreement.

Section 9. Compliance with All Laws

UNVERSITY agree that, during the performance of the services required pursuant to this Memo of Understanding, it and all its employees, volunteers, and subcontractors (if any) working under its direction shall strictly comply with all local, state or federal laws, ordinances, rules or

regulations controlling or limiting in any way its actions during such performance of the services required by this Memo of Understanding. Furthermore, each and every provision of law and clause required by law to be inserted in this Memo of Understanding shall be deemed to be inserted herein, and this Memo of Understanding shall be read and enforced as though it were included herein.

Section 10. Indemnification. UNIVERSITY agree to indemnify and hold harmless COMPEER from any and all losses, damages or liability arising out of negligence or other malfeasance or nonfeasance by UNIVERSITY, its employees, agents and servants, upon or in relation to the fulfillment of its responsibilities and obligations under this Memo of Understanding, including but not limited to, the provision of Services. Regardless of the nature of the claim, UNIVERSITY further agrees that if any claim or demand is asserted against it which reasonably may result in liability to COMPEER that UNIVERSITY shall give prompt notice thereof in writing to COMPEER and shall cooperate in the investigation of the claim and any defenses arising there from.

COMPEER agrees to indemnify and hold harmless UNIVERSITY from any and all losses, damages or liability arising out of negligence or other malfeasance or nonfeasance by COMPEER, its employees, agents and servants, upon or in relation to this Memo of Understanding or otherwise which results in loss to UNIVERSITY including, but not limited to, the payment for services under this Memo of Understanding. Regardless of the nature of the claim, COMPEER further agrees that if any claim or demand is asserted against it which reasonably may result in liability to UNIVERSITY that COMPEER shall give prompt notice thereof in writing to COMPEER and shall cooperate in the investigation of the claim and any defenses arising there from.

Section 11. Prohibition Against Assignment

UNIVERSITY shall be prohibited from assigning, transferring, conveying, subcontracting or otherwise disposing of this Memo of Understanding of any of its contents, or its right, title or interest therein, or of its power to perform the services required by this Memo of Understanding to any other person or corporation without the previous consent, in writing, of COMPEER.

Section 12. Extent of Memorandum of Understanding

The Memo of Understanding constitutes the entire and integrated agreement between and among the parties hereto and supersedes any and all prior negotiations, agreements and conditions, whether written or oral. Any modification or amendment to this Memo of Understanding shall be void unless it is in writing and signed by the parties.

Section 13. Non-Waiver

In the event that the terms and conditions of this Memo of Understanding are not strictly enforced by COMPEER, such non-enforcement shall not act as or be deemed to act as a waiver or modification of this Memo of Understanding, nor shall such non-enforcement prevent COMPEER from enforcing each and every term of this Memo of Understanding thereafter.

Section 14. Severability

If any provision of this Memo of Understanding is held invalid by a court of law, the remainder of this Memo of Understanding shall not be affected thereby if such remainder would then continue to conform to the laws of the State of New York.

Section 15. Law

This Memo of Understanding shall be governed by and under the laws of the State of New York. In the event that a dispute arises between the parties, venue for the resolution of such dispute shall be the County of Monroe, State of New York
