Go to any corner of the University of Rochester and you will see the impact of the leadership and philanthropy of Joseph C. Wilson '31 and Marie (Peggy) Curran Wilson.

With a bold vision for the University during the 20th century, the Wilsons took a burgeoning institution and helped launch it firmly onto the world stage as a major research University. In 1967, Joe and Peggy committed \$20 million, with \$15 million to fund professorships at the University. By the time of Joe's death in 1971, the Wilsons had given more than \$40 million. Among their greatest contributions were a charitable trust and a bequest. Peggy carried on their life of philanthropy, generously giving the University her home, a fine art collection, and other enduring support through the Marie C. and Joseph C. Wilson Foundation.

Joe and Peggy's generosity established a lasting and personal legacy. Their character, counsel, and spirit continue to live on at the University today, and the next generation of leaders has stepped forward by joining the Wilson Society.

As Simon alumni, their main goal was to provide general support for the Simon Business School. But because they also believe strongly in the power of a liberal arts education, they dedicated part of their CRUT to the School of Arts & Sciences to support the International Theatre Program, in honor of legendary English professor Russell Peck and his wife, Ruth. "For us, the ongoing potential to support what we care about is enormous," says Willett.

It was also important to the Willetts to complete the trifecta of philanthropic giving—annual support, endowment funding, and legacy giving.

Willett notes, "If you have it in your heart to do something for the University, during your lifetime and thereafter, the University can help you find the right pathway to accomplish your goal. Simply naming the University as a beneficiary of your will or retirement assets can have a powerful impact, and we are enormously grateful to those who honor the University in this way."
