This letter is in response to Provost Kuncf's correspondence of February 7, 2011, requesting registration of a proposed Master of Science (M.S.) program in Finance to be offered by the University of Rochester.

I am pleased to inform you that on the basis of our review the program detailed on the attached listing from the Inventory of Registered Programs is registered for general purposes under Subchapter A of the Regulations of the Commissioner of Education (Chapter II of Title 8 of the Official Compilation of Codes, Rules and Regulations of the State of New York) until September 1, 2012. After that date, registration will be extended annually until the Department's next review is conducted.

Please note that the attached Inventory listing records this program as ineligible for the Tuition Assistance Program (TAP) and Aid for Part-time Study (APTS). Only programs offered on a full-time basis are registered as TAP-eligible. Since this 36-credit master's degree program cannot be completed in one year, the program is considered a part-time program and therefore ineligible for TAP. Additionally, APTS awards are available for undergraduate study only. The program is eligible for Vietnam Veterans Tuition Awards (VVTA).

New registration is required for any existing curriculum in which major changes are made that affect its title, focus, design, requirements for completion, or mode of delivery. Therefore, I ask that you contact this office prior to initiating a significant change in this program.




This letter is in response to correspondence dated April 25, 2005 from Provost Phelps requesting registration of a proposed Accountancy program leading to the Master of Science degree to be offered by the University of Rochester. This letter also responds to Dr. Phelps' communication dated March 16, 2005 requesting the registration of title and curriculum changes, and the designation of licensure qualifying status, for the Accounting program leading to the Master of Business Administration degree.

I am pleased to inform you that based on our review the requested changes have been approved as indicated on the attached listing from the Inventory of Registered Programs. Moreover, on the basis of our review, the *Accountancy* program detailed on the attached listing from the Inventory is registered for professional purposes under Subchapter A of the Regulations of the Commissioner of Education (Chapter II of Title 8 of the Official Compilation of Codes, Rules and Regulations of the State of New York) until September 1, 2006. After that date, registration will be extended annually until the Department's next review is conducted.

The Board of Regents in 1998 amended the professional education requirements for licensure in the profession of certified public accountancy. All applicants for licensure in that profession on or after August 1, 2009 must present evidence of having satisfactorily completed a 150 semester-hour curriculum which is registered pursuant to Section 52.13(b), or determined by the State Education Department to be its equivalent. The two programs identified in the attachment - with the prerequisites identified by the University - now are designated as fulfilling the 150 semester-hour requirements for professional education programs in public accountancy.

New registration is required for any existing curriculum in which major changes are made that affect its title, focus, design, requirements for completion, or mode of delivery.
