

## 2020 Summer Housing

***Once signed and submitted, your summer housing and dining contract is binding.***

***We will be accepting summer housing and dining contracts starting Monday, April 20, 2020***

### GENERAL INFORMATION

We anticipate that summer housing will begin with ***all current students remaining in their current spaces.*** Students in summer housing will be required to move at some point during the summer. We will maintain the recommended social distancing requirements. Students will be housed in single occupancy rooms – double rooms will be used as singles. Everyone choosing summer housing is required to have a summer dining declining plan.

Applications must be received on time for us to consider requests. Please see the Application Process section for more information.

The University is not responsible for your personal property. You should consider obtaining insurance coverage for your personal property. **Linen service and storage facilities are not provided.**

### ELIGIBILITY & FEES

You must be registered as a full-time UR undergraduate student for the 2020-2021 academic year. You do not need to be registered for summer classes in order to participate in summer housing. Students who are currently in housing who will graduate in May are eligible to remain for summer housing (ends August 8).

All classes will be online for both summer sessions. There is no physical access to labs, libraries, offices, athletic facilities, or experiences that require students to be on campus. There is no timeline at this point suggesting when these restrictions may be lifted. Thus, only those students who are currently residing in residence halls are eligible to apply for summer housing. Exceptions may be granted for students living off campus whose leases have expired.

All contracts require a minimum stay of seven days. If you are only staying for one week, the rate is \$170.00. The weekly rate is reduced if you stay a second week or more. Please see the rate sheet for more information.

## RATE INFORMATION

There are two ways to schedule and be billed for summer housing.

<b>Billing by the Session:</b>	<b>Housing</b>	<b>Dining</b>
A1 – 5/18 – 6/13	\$644	\$610 (includes \$530 in Declining Balance)
A2 – 5/18 – 6/29	\$966	\$915 (includes \$800 in Declining Balance)
Full summer – 5/18- 8/7	\$1,886	\$1830 (includes \$1600 in Declining Balance)

**Billing by Weekly rate: \$161 per week.** Some students want to stay for a shorter period of time: a week, several weeks, or a month. Indicate the end date of your housing needs on the application.

***Please note: Summer housing for all students will start on 5/18. Once you leave housing, you may not return.***

## APPLICATION PROCESS

A signed Summer Housing and Dining Application and Contract must be on file by 5:00 p.m., May 8, 2020 at the Office for Residential Life, 020 Gates Wing Susan B. Anthony Hall, along with all appropriate fees or a signed payment plan in order to remain in your current room. Students who do not submit by May 8, 2020 may be relocated to an alternate assignment.

While students will not have to pick up a key or move to a new location at the start of summer housing, you will have to officially sign into summer housing to confirm your acceptance of the space for summer. You will receive an email with information about this sign-in process (location and hours) a few days before summer housing begins.

All summer residents are responsible for reading and abiding by the Summer Housing and Dining Contract as well as University policies and Residential Life policies and procedures. You can find policy information on the web via the Dean of Students page and the Residential Life page.

## CANCELLATION AND CONTRACT CHANGES

A student may cancel their contract before the start of Summer Housing by contacting us at [summerhousing@reslife.rochester.edu](mailto:summerhousing@reslife.rochester.edu) at least 7 days prior to the start of summer housing (5/18). Failure to give adequate notice of a cancellation will result in a charge for one week's housing (\$161).

Students who change their departure date must notify [summerhousing@reslife.rochester.edu](mailto:summerhousing@reslife.rochester.edu) at least 7 days prior to leaving or be billed for one week's housing (\$161).

Please note: Housing fees are based on the number of weeks a student contracts for (a week being Sunday-Saturday) with a one week minimum.

## SUMMER HOUSING SIGN-IN

The summer housing staff will send an email to all summer residents with sign-in information five or six days before the official start of summer housing.

Summer Housing ends on Saturday, August 8, 2020 at noon.

## PAYMENT INFORMATION

1. Only UR students enrolled for the fall 2020 semester are eligible for Summer Housing charges to be posted to their UR student bill. Student bill charges will be posted for the full contract period indicated. You will see this on your June bill. Summer housing charges placed on the term bill must be paid in full by July 10, 2020. Summer housing charges cannot be carried forward into the next academic year's billing cycles.
2. Summer Assistants, Summer RAs, ResLife Facilities student workers, Facilities Grounds workers, Orientation assistants – if you are hired by one of these groups, check the Summer Work Projects box on the Summer Housing Application/Contract. These programs will submit official lists of eligible students. If you start as a student employee in one of these areas but your status changes, you may be responsible for a portion of the summer housing fees.

## MICROFRIDGE RENTALS

**\*\*This service will be dependent upon the current guidelines surrounding the COVID19 Pandemic.**

Microfridge rentals will be available to students on a limited basis.

The cost for a Microfridge rental is \$120 regardless of length of stay. Pay this by check or money order only. Payment is due with the housing contract. This check or money order must be made out to: University of Rochester.

## BRIDGE CONTRACT

Undergraduate students enrolled for the 2020-2021 academic year, with a room assignment in University housing for the 2020 fall semester, will be given the opportunity to extend their Summer Housing Contract for the period August 8, 2020 – August 20, 2020.

***Dining Plans are not required during the bridge period.***

Eligible students will receive information about moving from summer housing to fall housing assignments as the summer progresses. You will be required to move during the stated period.

Students who choose the bridge contract option MUST move from their summer assignment into their fall assignment before they leave campus for any period of time between the bridge dates.
